The University of Patras and Xi'an Shiyou University, wishing to promote co-operation between the two institutions in education and in academic research, agree to explore:

- g. the exchange of information, including the results of teaching and research collaboration;

- h. any other activities viewed to be mutually beneficial.

The terms of co-operation for each specific activity implemented under this Memorandum of Understanding (MoU) shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity and will be the subject of separate agreements. In addition, in this Memorandum of Understanding partner organisations mutually accept their respective criteria and procedures for quality assurance, assessment, validation and recognition of knowledge, skills and competence for the purpose of transferring credit.

4. Assessment, documentation, validation and recognition

By signing this Memorandum of Understanding we confirm that we have discussed the procedures for assessment, documentation, validation and recognition and agree on how it is done.

5. Validity of this Memorandum of Understanding

本谅解备忘录有效期

This MoU becomes effective from the day the representatives of both institutions affix their signatures below, and will continue for an initial period from 3 to 5 years, whereupon it shall be reviewed and may be extended by the mutual written agreement of both institutions. This MoU may be revised through the mutual agreement of both institutions and may be terminated by either party upon giving six months' written notice signed by the MoU supervisor.

6. Evaluation and review process

Any use of the names 'University of Patras' or 'Xi'an Shiyou University', including any of its constituent schools, departments, programmes or logos, relating in any way to the activities described in this MoU, shall be subject to prior written approval.
